# QUALIFICATION FOR MEMBERSHIP

## Article IV

Section 2. Active members shall be such persons who are either proprietors, managers, assistant managers, secretaries, performers and their booking agents or representatives, together with musicians identified with circuses, carnivals, fair associations, parks, wild west shows and chautauquas; also, agents, auditors, car managers, legal adjusters, owners, secretaries, treasurers and concessionaires identified with outdoor amusements, as above specified; also professional athletes of all classes; also professional bicycle riders, automobile racers and aviators, together with their managers, representatives, booking agents; also bill-posters; also proprietors, managers, editors, assistant editors and reporters of daily, weekly, monthly theatrical, amusement and sporting papers, magazines and journals; also theatrical passenger and traffic agents; also amusement editors, sporting editors of daily, weekly or monthly papers; also actors, of the screen or speaking stage; also any person who is not now, but who was previously connected with or served in any of the foregoing capacities for a period of one year.

Section 3. The Board of Governors may admit manufacturers of managers who are universally recognized by the outdoor amusement professions, as principally or exclusively engaged in the sale or manufacture of outdoor show commodities.

Section 4. No person shall be accepted as an active member unless they be a citizen of the United States of America or of the Dominion of Canada, of sound mind and body, good character and over the age of nineteen (19) years, and must have had no less than one year's actual service in any of the capacities enumerated in section Two or Three of this Article.
